NEW MOBILE GARBAGE BIN DISTRIBUTION BY ALAM FLORA

Kuala Lumpur, 18 August 2024 – Alam Flora Sdn. Bhd. (Alam Flora), a subsidiary of Malakoff Corporation Berhad (Malakoff), has distributed 100 units of 120-litre mobile garbage bins (MGBs) to residents in Taman Sri Rampai, Kuala Lumpur, to replace old bins that have been in use for more than 10 years. This initiative is part of Alam Flora's ongoing efforts to modernise and improve the efficiency of waste management in its service areas.

YB Nik Nazmi Nik Ahmad, Minister of Natural Resources and Environmental Sustainability, who is also the Member of Parliament for Setiawangsa, attended the distribution to his constituents. His involvement highlighted the government's commitment to improving the cleanliness and quality of life in residential areas, while providing strong moral support to the local community. Also present were the Director of SWCorp Federal Territory, Abd Karim Bin Salim.

According to Badrulhisyam Fauzi, the Covering Chief Executive Officer of Alam Flora, the mobile garbage bins are part of the company's continuous efforts to raise public awareness about effective waste management. These bins are specifically designed to improve waste management in residential areas, with the aim of making local neighbourhoods cleaner and more comfortable for residents.

This initiative aligns with the Government's vision to improve waste management, encouraging local residents to actively participate in maintaining a clean environment and making full use of the newly distributed mobile garbage bins.

The mobile garbage bin distribution programme, which commenced in April 2024 in Kuala Lumpur, Pahang and Putrajaya, will continue until December 2025, aiming to distribute a total of 274,000 unit of 120 litter bins for residential areas. Additionally, the distribution of 21,464 units of 660 litter-sized bins for commercial areas and 19,760 units of 240 litter- sized for waste collection points has already begun within the three Alam Flora service areas.

Distribution highlights for MGB120L Bins:

- **Kuala Lumpur:** A total of 113,245 units have been allocated, with 4,112 unit successfully distributed between April 2024 and July 2024.
- **Putrajaya:** Out of 5,060 allocated bins, 645 units have been distributed during the same period.

- **Pahang:** With the largest allocation of 155,961 units, Pahang has achieved a remarkable distribution of 14,591 units as of July 2024.

This initiative is part of Malakoff's business pillar, Malakoff Environmental Solutions' aspiration to focus on environmental management and solutions that are dedicated to serving communities and the planet. It is also in line with the UN SDG Goal No. 11 where it aims at making cities and human settlements inclusive, safe, resilient and sustainable, aligned with Malakoff's overarching purpose of 'Enhancing Life, Enriching Communities'.
